BRUER KERSHNER

PROFESSIONAL DEVELOPMENT

VALUATION WORKSHOP

Justin Petlakh and Brendan Wewer from JSR Appraisal Group and Mid-Atlantic Valuation Group led this semester's appraisal valuation workshop. They worked through an open-ended case study that answered questions that real estate professionals ask throughout the commercial real estate investment and development process. Students were asked to come to their own supported calculations for market value, reconciled cost to construct, and residual value.

LICENSEE PANEL

This panel was led by licensed student agents Jake Lewis, Theresa Luu, and Ravi Shah. They joined TREO to share their experience getting their real estate licenses and starting their career. The panelists answered questions about the process of getting licensed, common license test questions, and post-licensing work. Each panelist brought a unique background including wholesale, leasing, and sales.

LOAN UNDERWRITING WORKSHOP

Chris Tereo from iFundCities led this workshop. He walked the group through the initial process of development from site selection to loan origination calculations. Members used the same excel worksheet Chris and his team uses to originate loans for his business and worked with a real example of a development financed near Temple's campus. Students were able to see the calculations behind a construction loan and a refinance.








FUNDRAISING
